To secure payment for all purchases from Seaport Meat Company, now and in the future, Buyer hereby grants Seaport Meat Company a continuing security interest in all of Buyer's presently owned or hereafter acquired (a) goods, (b) instruments, (c) Chattel paper, (d) books and records, (e) accounts, (O accounts receivable, (g) general intangibles, and (h) payment intangibles together with all proceeds and all Support obligations thereof. The following constitute Buyer defaults: Non-payment in timely fashion of Buyer's indebtedness to Seaport Meat Company, bankruptcy, insolvency, or assignment for the benefit of creditors; misrepresentation in respect of any provision of this or any Agreement between Seaport Meat Company and Buyer. In the event of default Seaport Meat Company may declare all unpaid balances due. Buyer authorizes Seaport Meat Company to file a financing statement describing the collateral. Buyer's signature attests financial responsibility and willingness to pay our invoices in accordance with Seaport Meat Company's terms.

TERMS: Buyer agrees to pay all invoices within credit terms granted by Seaport Meat Company and to pay a service charge of 1.5 % **per month** which is an **annual percentage rate of 18%** on all overdue balances. Buyer further agrees that the site of venue for litigation between the parties is San Diego County and the prevailing patty in an action is entitled to reasonable attorney fees and costs. Seaport Meat Company's liability for any damages claimed by Buyer is limited to the purchase of the goods or services in question.
